

Facility Use Fees

Parking Strip (for vendors)	\$50 Daily / \$300 Weekly / \$1000 Monthly

Security Deposit

A refundable security deposit of **\$500** is required at the time of booking. The deposit will be returned following a post-event inspection, provided that:

- The facility is left in clean condition,
- No property is damaged or missing,
- All terms of use have been followed (see Facility Use Policies).

Sound Equipment

Use fees do not include the sanctuary's sound system. For access, an SVUUS sound technician must be scheduled in advance. An additional fee paid directly to the technician applies.

Ministerial Services

Our minister is available to officiate weddings, memorials, and other ceremonies for a separate fee. Please contact the office to discuss availability and honorarium.

Custodial Fees

Users are expected to clean the facility after their event in accordance with SVUUS Facility Use Policies. If custodial services are required, a base fee of **\$50** will be charged. Additional fees may apply depending on the scope of services needed.

Additional Rate Information

Social Hall Capacity

The base rental rate includes up to **40 guests**. A surcharge of **\$5.00 per additional guest** will apply for larger groups.

Reservation as a Contingency ("Back-Up")

If the facility is reserved as a back-up location:

- The full rental fee, as indicated on our rate sheet, will be charged.
- If no other rental requests are received during your hold period, **50% of the fee may be refunded**.
- If other opportunities to rent the space are declined due to your reservation, no refund will be given.

Mission Compatibility

All events held at SVUUS must align with our values and principles. Specifically, we affirm the **inherent worth and dignity of all people**. Events or groups must be inclusive and respectful of:

- The LGBTQIA+ community,
- People of all races and ethnic backgrounds,
- Gender equality and reproductive autonomy.

Events found to be in conflict with these values will be denied or canceled.
