SVUUS MEETING RULES OF ORDER

DEFINITIONS

- 1. The Board of Trustees schedules Community Discussion Meetings to cover community discussions of a designated topic. The Board appoints the chair/moderator. These meetings are intended to establish a consensus and/or gather ideas, congregational sentiment, etc. The meeting results guide the Board in their decision-making and in preparing proposals for action at congregational business meetings. Both members and friends of South Valley UU Society may participate. Straw polls, if used, are not binding or official. They merely indicate the views of those at the meeting. It is suggested that comments be given in the "I think/it seems to me" format, with consideration to others' feelings and with a willingness to maintain an open mind. The purpose of the meeting and simple ground rules of courtesy, brevity, etc., should be reviewed at the opening of every community meeting.
- 2. The Board calls Official Congregational Business Meetings/Annual Meetings for the purpose of reviewing and approving budgets, electing officers, calling ministers, bylaws changes, etc. The call to meetings and business meetings shall follow the Society's bylaws, Robert's Rules of Order as the parliamentary authority, and suggested meeting rules. At the beginning of each meeting, it is strongly recommended that meeting rules such as those listed below be presented for adoption at all official business meetings of the Society.

MEETING RULES (SUGGESTED)

The proposed meeting rules will be presented at the opening of each business meeting for adoption by the delegates. A two-thirds vote is required for their adoption; the same vote – two-thirds – is required to amend or rescind a rule. Any standing rule (except one prescribing the parliamentary authority and those that are bylaws provisions) may be suspended for a particular specified purpose by a majority vote, even if the rule requires a two-thirds vote to adopt. The purposes of these rules are to expedite business in a clear and orderly fashion, to give all members an opportunity to be heard, and to protect the rights of the minority.

Representation

- 1. Each individual who shall speak shall be a member or friend of the Society.
- 2. Each member shall cast no more than one vote on an issue.
- 3. The meeting shall be open to all members and friends of South Valley UU Society, but only members shall be entitled to vote and offer motions, legislative items, and resolutions.

Debate

- 1. Any member desiring to speak to the question under discussion shall stand (if physically able). When recognized, they shall speak into a microphone (provided) to allow all attendees to hear. Speakers shall first identify themselves and state their membership status.
- 2. No one shall speak for longer than 2 minutes at a time without the unanimous consent of the convention.
- 3. Debate shall follow a pro/con format until all viewpoints are heard. At that time, more points on any side may be heard.
- 4. No one shall be allowed to speak a second time on the same question as long as any person who has not spoken to that question desires the floor. This rule does not apply to the committee chair making a report or a speaker presenting a subject/issue.
- 5. No one shall speak more than twice on the same question.

STANDARD "ROBERTS RULES" PROCEDURES

- Call the Question. This is used to end the debate and call for an immediate vote on the motion. It requires a second and a simple majority vote. There is no discussion on a call for "Question."
- *Point of Order*. To be directed to the chair. Point of Order is used to inquire if the Meeting Rules are being followed.
- *Point of Information*. To be used for clarification or questions on the motion. A Point of Information should not be used as a method to enter into a discussion.
- Question or Point of Privilege. This takes precedence over all other motions except three: Recess, Adjourn, and Fix the Time to Adjourn. It cannot interrupt voting or verification of a vote. It does not require a second, cannot be amended, and is not debatable. It is ruled upon by the chair.
- Friendly Amendment. Although not supported by Robert's Rules, South Valley has a history of allowing Friendly Amendments from the floor. After recognition by the chair, the member offers a friendly amendment, which is typically only a minor change from the existing motion. Both the maker of the original motion and the seconder need to agree for the amendment to the motion to take place.

PROPOSED AMENDMENTS TO BYLAWS

Section 10 - Leadership Succession Committee

Currently reads: "Nominees shall be members of the Society for at least six months prior to the Annual Congregational Business Meeting."

Proposed: "Nominees shall be members of the Society for at least six months prior to the beginning of their term of service."

Article VI Section 1 - Board of Trustees.

Currently reads: "Members of the Board of Trustees shall be members of this Society for at least six months prior to election and shall be at least 18 years of age."

Proposed: "Members of the Board of Trustees shall be members of this Society for at least six months prior to the beginning of their term of service and shall be at least 18 years of age."

Reasoning: We hold membership ceremonies in spring and in December. The current wording effectively screens out anyone joining in December, which is half of our new members. The terms actually start in July, which would still be six months after becoming a member. Most of our members are with us as friends for some time before they become members, and the Leadership Succession team can take this into account as they approach congregants for these positions.

It's been an amazing year here at South Valley Unitarian Universalist Society. MINISTER'S ANNUAL REPORT

Beloveds,

As I wrap up this fifth year of ministry with you, I am again moved to express just how wonderful an experience of shared ministry this has been. Our leadership and staff teams have been working diligently on all fronts, and it really shows up on Sunday mornings when I see streams of new people coming in our doors— and staying. At a time when the world is feeling upended and many people are struggling with despair, South Valley is a beacon of hope. And this is exactly what this community has long understood itself to be about and for. Our community is responding to our national context and the threat of authoritarianism by focusing on what can be done and with a commitment to our shared values.

This year kicked off with a focus on our building and grounds as a first step in working on our strategic plan. A year ago, we applied for funding through FEMA and were granted \$150,000 towards building improvements in the form of new doors, windows, and security upgrades. The project team has dedicated countless hours to meeting the grant requirements (which are extensive and complex), and we hope to be able to begin our planned projects in the next few months. Note: As these funds are already available at the state level, we are cautiously confident that they will remain available.

South Valley has a deep understanding of itself as a place, both physically and spiritually, in the wider community. We have known for several years that a major investment in our outdoor spaces was needed, and last year we began the work of creating a plan that could be implemented in stages over several years. Under the thoughtful leadership of the grounds team, we crafted a master plan and set our sights on stage one- replacement of the parking lot. But South Valley members surprised us by coming forward with an even bolder vision and timeline than we thought possible. Through gifts from members and a matching grant from our endowment fund, it became possible to take on the whole outside and make major improvements to accessibility, tree coverage, ease of use, and overall function of our urban space. And while many interrelated details are still being worked out, we remain hopeful that the work will begin in the coming weeks. As a community, we are investing in ourselves and the land we worship upon so that our space can be a place of refuge, beauty, and joy for all who seek us out.

Sunday worship has continued to be a bright spot in our offerings. The AV/Sound team has continued to make improvements in the online worship experience and in our post-service video production. We look forward to continued improvement with the addition of hearing support and the replacement of equipment that has reached its limit of usability. Our worship team has continued to delve deeply into the themes and "conversations" we seek to have within and among our community at this time. And with the new political context, we are seeing many more people join us- our attendance numbers keep growing. So, it's an exciting time to be sharing the good news of our community with a wider group of folks.

Our welcoming, starting point, and membership teams have coordinated to ensure new folks are engaged and able to find their way into connection and belonging as they desire. Our small groups- Soul Matters, HUUmanist, prayer shawl, CUUps, meditation, and religious transitions (among others) have engaged in a variety of topics and built spaces for explorations of ideas and bonds of friendship. Our Social Action team has led several successful initiatives (our day of service, food drive, shared plate), and our VOA meals for homeless youth have continued to be a vibrant ministry this year. Our board of trustees has worked diligently and with joy to provide leadership and direction for all committees and teams, and the resulting improvements in process for our finance, endowment, and leadership succession committees show in our bottom line, our investment strategies, and our new slate of trustees eager to serve.

We have had many changes as well in our staff team this year. Staffing for part-time positions is always a challenge, and we certainly have had our share of challenges this year. Many amazing volunteers have held our music direction and religious exploration program for children and youth. We look forward to settling in with our new music director over the summer months. In the fall, we will begin our search for a Director of Religious Exploration and trust our interim leader, Cam Adams, to shepherd us from now until then. Our youth programming has remained focused on incorporating the many new families and supporting teachers to lead thoughtful lessons. And our vocal choir is back on track to prepare monthly

music offerings for worship. It has been a test of patience and willingness to sit with ambiguity, and I appreciate everyone for sticking with the changes this past year.

As I finish this letter to you, I am deeply aware that my sabbatical is soon arriving. I am excited to venture into a less busy time and hope there will be new spaces for rest and renewal. I will really miss you all while I am away- South Valley is a huge part of my life, and I look forward to returning in the fall and hearing what good trouble you have been up to.

The Audio/Visual Team continues to play a vital role in enhancing the worship experience at SVUUS, both in-person and online. Each week, a dedicated group of volunteers—including a sound mixer, video technician, Zoom host, and slide presenter—ensures high-quality sound during services and produces recordings for our YouTube channel.

Through the leadership of Palmer Pattison, the team implemented a weekly planning meeting for those involved in the upcoming Sunday service. This initiative has significantly improved coordination and helped ensure a smoother, more cohesive worship experience for both attendees and worship leaders.

Our technology continues to evolve to meet the needs of our hybrid community. We regularly welcome 20+ households via Zoom each Sunday, and more who watch the service recordings later. These recordings are edited by Palmer, with chapter markers thoughtfully added by Maureen, allowing viewers to navigate the service with ease. In collaboration with Rev. Lora, the team has developed a list of recommended technology upgrades, which has been submitted as part of next year's budget for Board consideration.

As we continue to improve our technical capabilities, we remain mindful of maintaining a system accessible to lay volunteers. We are deeply grateful for Palmer's professional expertise and commitment, and we look forward to this essential ministry's continued growth and impact.

BIPOC Caucus (New Name TBD)

The BIPOC Caucus is a newly formed group at SVUUS, having just held its first gathering on May 4, 2025. The creation of this space reflects our ongoing commitment to equity and inclusion, as well as fostering a diverse, justice-seeking community. A BIPOC caucus centers the lived experiences of its members as it offers a vital opportunity for Black, Indigenous, and People of Color within our congregation to connect, share, and support one another.

Book Group

The SVUUS Book Group meets on the fourth Monday of each month in the Boardroom, with attendance ranging from 4 to 10 participants. Our selections include titles available through local libraries as well as online resources. Over the past year, we continued our exploration of anti-racism with discussions of *Master Slave, Husband Wife*, and *I'm Still Here*. We also enjoyed a month dedicated to poetry, led by Bob Speiser, and ventured into fantasy with *Cloud Cuckoo Land*.

This year, we were delighted to host a Logan UU congregation member for a potluck gathering and discussion of his book, *More Stars than Grains of Sand*. In addition, we have volunteered to organize and host the May 18th congregational potluck.

The Book Group remains open and welcoming to all participants, who are encouraged to join the conversation, whether or not they have finished the current book. We are always happy to receive suggestions for future reading selections.

Buddhist Meditation Group

This group, which includes Palmer Pattison, Zach Stickney, and several others, continues to support both South Valley members and newcomers in exploring Buddhist practice. We aim to nurture spiritual growth and contribute to the broader community's spiritual well-being.

There have been no particular challenges this year, and the group does not require a budget at this time. Looking ahead, we are excited to collaborate with the Religious Education (RE) program and continue to support SVUUS's spiritual life in new and meaningful ways.

Caring Circle

The Caring Circle currently includes a meal team of fifteen members and a transportation team of two members.

Throughout the year, the Caring Circle has provided meals and transportation to individuals facing life challenges, offering pastoral care to those undergoing surgeries or coping with bereavement. Our team connects with members through in-person and phone visits, with much of our outreach conducted over the phone.

Looking ahead to the next church year, Cort and Erin Bouldin will lead the circle's pastoral care aspect.

Continuing challenges for our team include ensuring congregants know they can reach out to us for support and recruiting and training additional volunteers to assist with this vital ministry.

Covenant of UU Pagans (CUUPS)

The Earth-centered spirituality group continues to foster deep connection through nature, community, and spiritual growth. Embracing a variety of Earth-based traditions, we are proud to be part of the congregation's vibrant and inclusive community life.

Over the past year, we have welcomed several new members. Our group studied *The Inner Temple of Witchcraft by Christopher Penczak* and participated in the Samhain service in October. We were also very proud to bring Celtic musician Celia Farran to our Sanctuary for an excellent performance.

Our monthly gatherings, held every 2^{nd} Sunday, provide a welcoming and supportive space for spiritual exploration, and we are always open to new participants, both in person and virtually. We invite anyone who is curious to join us in community and celebration.

Next year, we are planning on forming an Earth Circle group, which will meet on the second Sunday to have round table discussions of Pagan paths and do rituals. We are planning to hold a witches' tea in October, as well as other rituals later in the year.

Endowment Committee

Jordan's term on the Endowment Fund (EF) Committee ends on June 30, 2025; Ann's term concludes in 2026, and Paul's in 2027. One member is elected annually for a 3-year term, and two Board of Trustees members serve on the EF Committee.

The Endowment Fund was established to ensure the continuity and growth of the SVUUS and the causes it supports in perpetuity. It is managed by the Endowment Fund Committee as described in the bylaws.

The EF Committee meets quarterly to discuss business associated with the SVUUS Endowment Fund. The value of the fund as of 12/31/2024 was \$699,387. This value reflects \$617,109 invested in the Unitarian Universalist Association's Common Endowment Fund (UUCEF), plus \$82,278 in loans to the congregation. (\$30,000 was loaned to the Congregation for ARPA grants/security enhancements. \$52,278 is the remaining balance of monies loaned to the congregation between 2012 and 2014. In several recent years, the EF Committee has chosen to pay down the original \$65k balance by disbursing less than the allowed 3% of the fund values.)

The growth of South Valley's shares in the UUCEF increased 6.6% (Composite Net) for the 12 months ending 12/31/2024. UUCEF follows the principles of ESG (environmental, social, and governance) in applying UU values to fund investing. Our EF Committee is disappointed with this lackluster return, though it recognizes the importance of investing according to UU values.

Our EF Committee has voted to disburse a full 3% of the fund value to the congregation this year, totaling \$20,981, to support the budget process for the 2025-26 church year.

The EF Committee also voted in October 2024 to loan up to \$50,000 to the congregation, as seed money for American Rescue Plan Act projects for security enhancements to the church facilities. This money would be repaid as ARPA funds reimburse SV for these projects. The EF Committee voted to immediately disburse 30k for this purpose, with 20k to be disbursed later if needed. South Valley currently has this money invested in a CD, as security projects have not yet commenced.

In late 2024, the Board approached the EF Committee about the potential for a capital campaign to make improvements to the parking lot and asked if the EF Committee would consider a grant/disbursement to match congregant pledges. In December 2024, the EF Committee approved pursuing up to a \$60k disbursement as a 2-to-1 match for congregant donations/pledges towards this project. Since then, additional congregants have pledged monies to re-landscape the grounds to the south, north, and front of the church building, and it became apparent that improvements to the area west/behind the annex would be more efficiently done before landscaping the south & north sides. The EF Committee recognizes the potential for congregational growth if the facilities are improved, and noting the recent lackluster UUCEF performance, feels that investing in ourselves is a valuable and allowable use of our Endowment Fund. The EF Committee met on 3/31/2025 and approved pursuing a disbursement of up to \$110k from the fund to be used for improvements to our parking lot and landscaping. Per our By-Laws, because it exceeds the allowable 3% annual disbursement, this requires a 75% approval of members at our Annual Meeting.

Additionally, the EF Committee developed an informational brochure about the Endowment Fund, available in the church lobby.

Finance Committee

The SVUUS Finance Committee ensures SVUUS remains a financially sustainable community.

The Finance Committee interacts with the Endowment Committee, Stewardship, and Personnel Committees, though the need for direct involvement with the month-to-month review is seasonal and intermittent. We value the wise contributions from these critical financial teams, as well as our de facto members -- Board President and Minister.

The primary purpose of the Finance Committee is to review the monthly financial data provided by the Bookkeeper and Treasurer in a timely manner, and to provide feedback as needed to the SVUUS Board. Through the Board, the SVUUS community is then able to make input on financial decisions at the annual congregational meeting.

A secondary purpose is to advise the SVUUS Board on any budgetary concerns that may be noted and to provide recommendations for consideration by the SVUUS Board. Specifically, the Finance Team prepares a draft budget for the Board to consider and revise.

Accomplishments

- (1) Added two new members Pete Busche and Ende Lovato
- (2) Beginning the creation of the cyclical internal audit process.
- (3) Led a successful and on-time Budget process and captured some lessons learned.
- (4) The congregation has raised over \$100k this year from individuals for our CUUrb Appeal project. The Finance Team isn't taking credit, but wants to note what a huge accomplishment this has been.

Challenges

- (1) No official Chairperson aside from the Treasurer. Our ideal structure has a Finance Chair who is focused on running the meetings and digesting the details of our financial reports, and the Treasurer has oversight of the big picture, including an expanded vision for Stewardship.
- (2) Our process and relationship with accountants at Bountiful Peak continue to be uneven and, at times, contentious. Work in the coming year will need to be done to smooth this out with both South Valley and Bountiful staff, as well as to better track our contractual deliverables.

The SVUUS Library supports the spiritual growth of adults, children, and youth by offering a wide range of resources. Membership Committee

The role of the Membership Team is to ensure a coordinated welcome for newcomers, to help integrate newcomers into the life of the congregation, and to contact potential new members. Our team follows up with visitors who submit a Connection Card. We participate in presenting information about membership to the Starting Point small group classes several times a year. We also work with Rev. Lora to plan the new member ceremonies and host a gathering with the minister before each new member ceremony.

Throughout the past year, Rev. Lora and Lorri Quigley worked to update the membership lists and to personally reach out to lapsed members. Lorri updated the Breeze database to reflect the current active members, who total 157. The UUA membership database has been updated to reflect the accurate South Valley membership list.

A Dessert with the Minister gathering and a new member ceremony was held in December 2024, and another is planned for May 2025. The membership team reaches out to those who have been attending the Starting Point classes to see who may be interested in becoming official members. Sheri and Mac Lund and Scott and Laura Renshaw, the Starting Point leaders, have been helpful in recommending people who may be interested. Other recommendations have come from Rev. Lora and Brenda Voisard, President of the Board of Trustees. A total of twelve new members signed the membership book in 2024, and nineteen more joined in a ceremony held in May, 2025.

At the moment, our most significant challenge is finding personnel to join the committee. The current team is down to just two members. The team members have faced significant personal and family challenges, which have affected our ability to effectively carry out the mission of this team. New leadership for the Membership Team should be sought as Lorri Quigley is asking to step away from this role at the beginning of the next church year, July 2025. It would be helpful to add one or two new team members as well.

This year, the Staffing Committee focused on strengthening our team through key hires and internal process improvements. Thanks to their dedication, our building, grounds, and day-to-day operations have seen steady improvements, making it a true joy to gather in our Sanctuary each Sunday.

A special note of appreciation goes to our building manager, James Carlson, who has faithfully cared for our facility for over 20 years. His commitment and service are deeply valued by our entire community.

Prayer Shawl Ministry

The Prayer Shawl Circle is a small group of members and friends who come together monthly for spiritual growth and serve our church's members and friends, and occasionally the wider community. The prayer shawls are a physical reminder of our connectedness and that we are part of an interdependent web. Completed projects are provided to the minister and the Caring Circle to determine who might need comfort.

We would love to have more members join our group. All of us who are participating have found this group to be a positive experience. The group members donate their time and all project materials; no church funds are provided. We are all happy to help, but this needs to be recognized and considered if special projects are requested.

Religious Transitions Group

The Religious Transition Group (RTG) was established in 2003 because new people at South Valley coming here from another church needed a support group. Here they could frankly discuss their challenges about loved family members who expected that you would never change or have persistent questions. What are you to do with a spouse or child who expects whole-hearted participation at an upcoming religious rite? More than that, if you do not believe in your traditional faith anymore, what meaning does your life have?

To prepare for discussions, we established norms that included our dedication to kindness, confidentiality, honesty, mutual support, respectful perspective, constructive actions, and supporting "conversation, not conversion." I am pleased that these discussion norms were later utilized to aid South Valley in getting through a difficult time on another issue.

We support the dignity of religious freedom, which is as important today as it was 22 years ago. We support our participants' right not to be marginalized, shunned, or labelled. We support them through what happens, whether it be divorce or deciding to go back to their traditional practices.

I appreciate all the people who have attended RTG over the years, and our South Valley congregation supporting this unique face-to-face support group. Looking into the face of a supportive person does wonders for a soul's feeling accepted and normal.

Safety & Security

During the 2024-2025 FY, the entire team met five times, but many subcommittee meetings were also held. Our primary focus was on completing the National Security Grant administered by FEMA for Houses of Worship. In 2024, SVUUS was awarded \$149,991.

We thank Bob MacGillivray and Rev. Lora Young for completing our grant application. Bob Scarborough, James Carlson, and Mac Lund are the project managers, and work is underway to begin. Training was planned by Janis Reis and Ann Scarborough, and led by Dave McKean, Director of the Secure Community Network of Utah, including Stop the Bleed, Run Hide, Fight, Be Aware (Institutional

Awareness), and Guardian (Identify, Protect, Respond). A Fire Evacuation Drill for the congregation was done in the fall.

Currently, Zachary Stickney is assisting the team on the 2025 NSG (Nonprofit Security Grant) application, and the team is planning training for next year, including evacuation drills for the congregation with RE classes, shelter in place, lockdown, and lockout drills. We strive to provide a safe and secure worship space with volunteers trained to prevent harm by observing, interrupting, or reporting potential disturbances. We will need more volunteers to assist in this role; contact Ann Scarborough (952.994.1790) or Janis Ries (801.943.3676) to volunteer for an occasional Sunday commitment.

Soul Matters Small Sharing Groups

Some of you may be familiar with small groups held previously at SVUUS, called "Evensong." In 2021, Rev. Lora Young piloted a new UU small group ministry program called "Soul Matters". The monthly curriculum is created by Rev. Scott Tayler, a UU Minister and Family Therapist, and many UU congregations around the nation are engaged in Soul Matters.

What is a Soul Matters Small Sharing Group?

The format of this covenant group is specifically designed to help its participants learn and practice deep listening skills. This shared practice's wonderful benefit is the connection and closeness that emerges. The skills learned in Soul Matters can be applied to other relationships at home, work, and volunteer teams. We meet only once a month, 9-10 times a year.

Soul Matters' distinguishing characteristic is a focus on deep listening that helps us heal spiritual disconnection around three core spaces:

- Hold still the practice of offering space
- Hold at bay the practice of offering presence
- Hold out and hold up the practice of offering gratitude and noting meaningful connections

By engaging in deep listening, participants are called to move beyond the question of "What do you think?" into the deeper one of "Where are you willing to let your faith take you?"

This, ultimately, is why one joins a Soul Matters small group. Yes, you will encounter meaning. Yes, you will discover new friends. *But in the end, this is about recovering wholeness and the journey back home.*

Soul Matters is neither a "discussion group" nor a "therapy group," and requires monthly preparation for our 2-hour meetings. We unlearn bad habits of interrupting others, pre-planning our responses, and offering unasked-for advice! We practice new ways of being sensitive and respectful to others, and learning together becomes a balm for our hearts and minds.

**We currently have 3 Soul Matters groups facilitated by Sheri Lund, Susan Eyzaguirre, and Ann Scarborough. Brenda Voisard is our substitute facilitator. This past year, we attempted to recruit additional

facilitators, and we are delighted to welcome back Brenda Thomas! She and Shawna Cannon will be cofacilitating, and they will be meeting on the 4th Sunday of the month after the service, at the same time as Susan's group meets. A new Soul Matters Facilitator Training will be held on Wednesday, May 7th, in the Children's Chapel from 7-8:30 pm.

Starting Point Small Groups

We look forward to creating alternative Starting Point sessions for those unable to commit to the three weekly sessions. Starting Point is typically on hiatus during the summer months. Starting Point is definitely a great way to introduce new folks to the "AWESOMENESS" of our congregation!

The Stewardship Committee helps South Valley by assisting congregants to connect their giving to the staff and programs that make South Valley's mission happen, and making congregants feel seen and heard.

Conversations about giving to a cause like South Valley are often uplifting and affirming, as people share stories of what they get from South Valley, of the general joy of sharing, and of the fire people have for the mission of South Valley. However, with any conversation about money, there is always the risk of an awkward interaction.

I have used my chairmanship to expand the usage of Breeze, adding fields and processes to the standard work of several committees to foster inter-committee sharing of information, to improve committee communication and outreach to congregants.

The pledge campaign for the '25-'26 church has just wrapped up. Thank you to everyone who's made it a success!

Rather than shooting for a specific single figure, we shot for a range, knowing that at the very low end of the range (\$300K or so), we can fund much of what we consider our core necessities, while at the higher end of the range (\$336K), we can fund additional items and programs.

We have definite pledges of \$325K, which will add to our core necessities, and several additional not-asdefinite amounts likely to come through that could put us near or even over \$336K. The Treasurer and Finance Team will give more details about the items we can include this year.

YRC Meals For Youth Program


As a community, we continued serving two to three meals each month throughout the 2024-25 church year at the Volunteers of America Youth Resource Center (YRC) in downtown Salt Lake City. This program is one of our longest-running service programs at South Valley - entering our 14th year!

The YRC is a drop-in resource center and emergency shelter for youth ages 15-22 who are experiencing or at-risk of homelessness. Three hot meals are provided daily, largely by volunteer groups like ours, for ~30 to 50 youth. Each of the meals we provide is planned and coordinated by a South Valley "Crew Lead," and typically 3 to 6 South Valley members and friends will volunteer to provide and/or prepare menu items at home or at the center, serve at the center, and clean up. The South Valley Social Action budget includes some dollars to help volunteers cover expenses as needed, plus we can use a variety of food items available in the YRC's pantry as well (i.e., dry, and canned goods, frozen meats, dairy items, condiments, etc.). Ages 16+ are allowed to serve at the center, but younger children and youth can participate at home, preparing food like baking cookies, putting together a salad or main dish, and delivering it to the center.

This program aligns nicely with our UU principles and values, and South Valley's mission. As we serve together, we nurture generosity within our faith community and connect more deeply with one another and our larger community.

We are committed to providing three meals each month for the duration of the 2025 calendar year, and we are always looking for volunteers and more Crew Leads. Susan Eyzaguirre and Joshua Johanson are willing to help those who want to give it a try. Let us know if you are interested; we are happy to co-lead or help plan meals with you.








"LocalScaped" Front Yard and planter beds with native, droughttolerant plants and cobble.






Our New SOUTH FOREST

"South Valley's Natural Landscape"














Potential site for future sign.

Our New/Future NORTH COURTYARD "South Valley's Back Yard"



















"StormTech" System
